




TOKENOMICS

TOKEN DISTRIBUTION MODEL



1. Ecosystem and Community (35%)

This is the largest allocation, designed to drive user adoption and engagement.

- **Staking Rewards (25%):** Allocated to reward users who stake their \$NEXC tokens. This directly supports the platform's utility and provides a consistent incentive for long-term holding.
- Performance & Referral Bonuses (5%): Used for rewarding users who
 achieve specific investment fund performance milestones or refer new
 users, driving active participation and growth.

 Airdrops & Community Grants (5%): A strategic reserve for one-time airdrops to bootstrap the initial user base and for providing grants to developers or community members who contribute to the NexCoin[™] ecosystem.

2. Team, Advisors, and Future Hires (19%)

This allocation ensures the long-term commitment and professional growth of the project.

- Core Team (12%): Reserved for the founding team members, Rami, Fahad, and the three founding members. These tokens will have a vesting schedule (e.g., 1-year cliff, 3-year linear vesting).
- Advisors (3%): Dedicated to legal, financial, and exchange partnership advisors, with a similar vesting schedule to ensure their continued support and guidance.
- Future Talent (4%): A strategic reserve for attracting and compensating future hires as the company expands its operations and requires specialized talent.

3. Investors (10%)

This category is for the early financial backers of the project.

- Seed & Private Sale Investors (5%): Allocated to the initial investors who provided critical capital. Their tokens will have a vesting schedule (e.g., a 6-month cliff, 18-24 month linear vesting) to prevent market volatility.
- **Strategic Partners (5%):** A smaller allocation for investors or partners who bring significant value beyond capital, such as key industry connections or technology.

4. Public Sale (10%)

This is the only category with an immediate unlock, providing initial market liquidity.

• **Public Sale:** A straightforward allocation for the public to acquire tokens, ensuring a wide and decentralized initial distribution.

5. Treasury and Operational Reserve (26%)

This serves as the project's long-term operational and financial backbone.

- Company Treasury (5%): A non-vested reserve for ongoing operational expenses, legal fees, audits, and compliance costs.
- Marketing & Liquidity Provision (3%): A dedicated fund for post-listing marketing, exchange liquidity, and ensuring a healthy trading environment.
- **NexBank[™] Reserve (9%):** A specific reserve for the development and future operational needs of the NexBank[™] service, showing a forward-looking plan for the project's evolution.
- **NexCard™ Reserve (9%):** A specific reserve for the development and future operational needs of the NexCard™ service, showing a forward-looking plan for the project's evolution.

TOKEN VESTING SCHEDULE



Below is a detailed explanation of the vesting schedule (Token Unlocks) for each sub-category of token distribution, designed to provide a comprehensive overview for the investors and the potential centralized exchanges.

1. Ecosystem and Community (35%)

- Staking Rewards (25%): Tokens in this sub-category have no cliff and will be unlocked gradually over a period of 4 years. The release is tied to an "emissions schedule" which means a set number of tokens will be released on a regular basis (Monhtly) to reward users who stake their \$NEXC tokens. This ensures a consistent supply to incentivize network participation and is not subject to a single unlock event.
- Performance & Referral Bonuses (5%): Similar to staking rewards, these
 tokens have no cliff and will be unlocked over 4 years, based on the growth
 and performance of the platform. This is a dynamic schedule that rewards
 active users and is not a fixed, time-based release.
- Airdrops & Community Grants (5%): This is a flexible, uncapped release.
 Tokens are distributed as needed for specific marketing events, airdrops to new users, or grants to community developers. This allows for adaptability in your growth strategy.

2. Team, Advisors, and Future Hires (19%)

- Core Team (12%): These tokens are subject to a 1-year cliff. This means none of the tokens will be unlocked for the first year after the Token Generation Event (TGE). After the 1-year cliff, the tokens will be unlocked on a monthly basis over the next 3 years. This 4-year total vesting period is a standard practice that demonstrates a strong long-term commitment from the founding team.
- Advisors (3%): The vesting schedule for advisors is the same as the core team: a 1-year cliff followed by a 3-year monthly linear unlock. This ensures their ongoing involvement and alignment with the project's success.
- Future Talent (4%): This reserve is also subject to the same vesting schedule to ensure new hires are similarly incentivized for long-term commitment.

3. Investors (10%)

- Seed & Private Sale (5%): These tokens have a 6-month cliff, meaning they cannot be sold for the first six months. After the cliff, they will be unlocked on a monthly basis over the next 18 months, resulting in a total vesting period of 2 years. This is crucial for preventing a large sell-off immediately after the token's listing.
- **Strategic Partners (5%):** The vesting schedule for strategic partners is identical to that of seed and private sale investors to ensure their interests are similarly aligned with market stability.

4. Public Sale (10%)

 Public Sale (10%): All tokens in this category will be 100% unlocked at the Token Generation Event (TGE). This provides immediate liquidity for trading on the CEX and ensures that the public has a fair and open opportunity to participate from day one.

5. Treasury and Operational Reserve (26%)

- Company Treasury (5%): Tokens in this reserve have no vesting schedule and are unlocked as needed for operational costs. However, CEXs often require these funds to be held in a multi-signature wallet to demonstrate good governance and transparency.
- Marketing & Liquidity Provision (3%): These tokens are also unlocked as needed to provide liquidity to exchanges and fund ongoing marketing efforts.
- **NexBank[™] Reserve (9%):** This is a non-vested reserve that can be used for the development and future operations of the NexBank[™] service.




